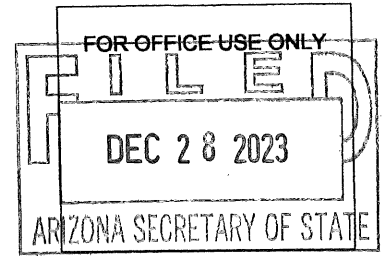

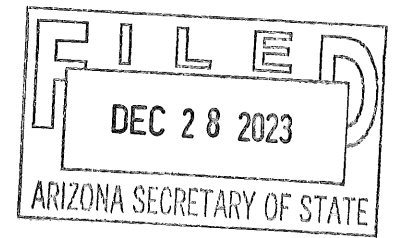

The Wesson Medicinal Act

If proposition passes, Medicinal Psychedelic Mushrooms will become medically legal for Medical Mushroom Card Holders. After getting a prescription for one from a licensed doctor, like a Medical Marijuana Card required to use Marijuana before it became recreationally legal. Medical Mushroom Dispensaries separate from Marijuana Dispensaries will open up around the State, only for Medical Mushroom Card holders though, and those without Medical Mushroom Cards that are caught in possession of Medical Mushrooms for personal use will only receive a Class 1 Misdemeanor instead of a Class 6 Felony as long as it is for personal use and if you sell it without a Dispensary License as long as it isn't laced with other drugs and not contaminated with mold or bacteria then it is only a Class 6 Felony Distribution charge instead of a Class 3 Felony Manslaughter Charge.
